The HIPH Board has issued a number of letters concerning many important and priority matters regarding the activities of the Association's member companies including to:

- Ministry of the Environment, Department of Air and Climate Protection, handing over the EUROFER letter regarding a new aspect regarding the draft Free Allocation Regulation under the EU Emissions Trading System (EU ETS) 23.10.2018.
- Ministry of Investment and Development, Department of Architecture, Construction and Surveying, about the draft Ministry of Infrastructure and Development Regulation amending the regulation on the manner of declaring the performance in use of construction products and the method of marking thereof with a construction mark 24.10.2018.
- Ministry of Entrepreneurship and Technology about supporting the ongoing working pre-consultations regarding the introduction in Poland of an indirect carbon cost compensation scheme. 24.10.2018.

HIPH Council Session

December 3, 2018 saw the HIPH Council holding a session at the Polish Steel Association premises. At the beginning, a company representing the bearing



manufacturer RKR Bearing Industries and LIEBHERR Components delivered a short presentation.

In the further part of the meeting, the Council Members became updated on the current situation on the steel, coke and refractory markets in 2018 and on topics related to modification of trade defence instruments (MTDI), ongoing safeguarding measures and applicable AD/AS duties. The Council also became acquainted with the plan of activities undertaken by the Chamber's Board within the framework of the formed coalitions: WG on Energy-Intensive Industries and issues covered by the cooperation with EY.

On December 13-14, 2018 a conference of HIPH Member Companies was held in Ustroń. The meeting discussed the following issues: steel, coke and refractory market performance, EU steel trade with third countries. The current state of safeguarding measures and operating trade defence measures in international steel and raw materials for metallurgy trades were presented.
